### JOB PURPOSE

- Contribute towards writing separate sections for high quality academic papers
- Support the Principal Investigator on weekly routine matters related to the project
- Participate in relevant research group meetings
- Ensure that weekly tasks are prioritised and completed within agreed timeframes
- Help present information on research progress and outcomes to relevant parties
- Help the research team achieve research objectives and deadlines
- Form and maintain positive and productive relationships with research colleagues
